*Country of tax residence: Country in which the person/entity is liable to pay tax on the global income earned and is liable to tax therein by reason of his domicile, residence, place of management or any other criterion of a similar nature. In general, tax residence is the country/ countries in which you live and pay income tax. If you have a multiple residency you can be paying income tax in more than one country and thus have multiple tax identification numbers. For example a person residing in India, will be liable to pay tax in India on his/her global income but may have TIN of countries other than India like USA and Japan as he/she is earning income from business sourced from these countries. Here his/her country of tax residence will be "INDIA" and TIN issuing country 2 will be USA and 3 will be Japan. For more information on country of tax residence, please consult your tax advisor. In case of multiple tax residency, update TIN issuing country 2 and 3.														to se						
***TIN issuing country: This is the "Name of the TIN issuing country" mentioned on the TIN card. E.g. If a person is earning income from different countries, he/ she may have TIN of all these countries and accordingly the TIN issuing country mentioned on each TIN will be different.														ve						
**TIN:Tax-Payer Identification Number (TIN) is an identification number allotted to ensure the unique identification of the person/entity for tax purposes and is allotted by tax department/governmental bodies of respective countries of tax residence. E.g. In India it is known as Permanent Account Number (PAN), in USA it is known as TIN, etc. Some countries do not issue a TIN. However, these countries often utilize some other identification card for tax purposes. Social security number, insurance number and resident registration number are few examples of alternate options used by few countries for tax identification.														ne
